This form must be signed by each traveller over the age of 18. The signing and returning of this release is a condition of our acceptance of you as a traveller with Wild Earth Adventures:

I hereby expressly release and waive, on my behalf and that of my heirs, any and all claims against Wild Earth Adventures, its agents (Rainbow Mountain Outfitting, Kynoch Adventures, Mahikan Trails Inc, Spirit of the West Adventures, Quadra Island Kayak, Stubbs Whale Watching, Sea to Sky Expeditions, and all others), employees, officials, and shareholders for any injury, death, illness, damages, costs or other losses resulting from my voluntary participation in the Wild Earth Adventures Tour Programme arising from any event or cause that is either:

- a)** attributable to me;
- b)** attributable to a third party unconnected with the provision of services by Wild Earth Adventures to me;
- c)** due to unusual and unforeseeable circumstances beyond the control of Wild Earth Adventures that could not have been avoided even if all due care had been taken;
- d)** due to an event which even with all due care could not have been foreseen or forestalled by Wild Earth Adventures.

I acknowledge that, for the purposes of this release, events which could not, even with all due care, have been foreseen or forestalled by Wild Earth Adventures shall include without limitation Acts of God, weather, detention, annoyance, delays and expenses arising from quarantine, strikes, theft, pilferage, force majeure, military, political or terrorist action, civil disturbances, government restrictions, failure of any means of conveyance to arrive or depart as scheduled, discrepancies or changes in transit over which Wild Earth Adventures have no control.

I also acknowledge that Wild Earth Adventures organises trips in areas where standards of accommodation, transport, safety, hygiene, medical and other facilities may, at times, be lower than those I would normally expect or where political instability or other factors involve a risk of injury, psychological trauma, disease, loss or damage to property, inconvenience and discomfort or may require changes to the itinerary, accommodation and modes of transport without notice due to circumstances beyond the control of Wild Earth Adventures. I accept the risks inherent in the Wild Earth Adventures Tour Programme, including, but not limited to, the risks of air travel, walking, hiking, boating, rafting, swimming, snorkeling, and travelling in land vehicles.

I further accept the risks inherent in encounters with animals. I understand that animal encounters are an ingredient of any Wild Earth Adventures Tour and that wild animals cannot be controlled, nor can their actions be accurately predicted. I also understand that adverse and dangerous conditions can occur in both warm and cold weather, even when I am not participating in specific wildlife excursions.

I agree to follow the safety directions of guides and drivers and exercise reasonable care in all activities in which I participate. I accept that Wild Earth Adventures has the right to prohibit me from continuing on a trip with no right of refund if, in its opinion, my actions pose a threat to my safety or that of others, or to the wildlife, or if my actions or behaviour are seriously jeopardizing the enjoyment of the trip for others.
